Split Your Sides with Laughter!

First edition of the 'Attilio Mussino' International Illustration Competition for young illustrators aged between 16 and 30 from all over the world.

The Municipality of Vernante together with Imaginé, small festival of illustrated narrations, is happy to present the first edition of the 'Attilio Mussino' International Illustration Competition aimed at young illustrators aged between 16 and 30 from all over the world.

Perhaps not everyone knows that Attilio Mussino, a well-known illustrator of newspapers and children's books, was also one of the most important illustrators of Collodi's Pinocchio. It was he who, on the occasion of the publication of the first luxury edition of the tale by the publisher Bemporad, created the first color image of Pinocchio that we all know so well: a little green dress and pointed white hat.

Precisely in order to celebrate the art of illustration from Mussino's work, the theme of the competition will be Split Your Sides with Laughter, an expression that has become part of our common language since the Pinocchio book.

In a less known episode of the story, Pinocchio has to cross a road that is blocked by a large snake with a smoking tail. The puppet sees the snake lying motionless in the road, thinks it is dead and tries to step over it: but the snake jerks out of the way and Pinocchio, frightened, stumbles and falls into the mud, being left with his legs in the air: 'At the sight of that puppet, who was running headlong with incredible speed, the Snake was seized by such a convulsion of laughter, that laughing, laughing, laughing, in the end, from the exertion of too much laughing, a vein was torn in his chest: and that time he really died'. And here Pinocchio's greatest fear is extinguished in an instant by a roaring laugh. Split Your Sides with Laughter means laughing a lot, inordinately, so much so that you almost burst out, so that your skin cracks, your face changes. We want to see what noise your laughter makes!

Each participant may only submit one vertical board and send it digitally to info@festivalimagine.it by Friday 14 March 2025.

What do you win?

The first prize of the competition consists of a **500-euro reward**, and the opportunity to exhibit and present one's work during the Imaginé festival to be held in the summer in Vernante. Among the guests of this new edition, special space will be given to the Topipittori publishing house.

Furthermore, all the illustrations that the jury deems most deserving will become part of the competition catalogue.

Competition notices

Art. 1

The Municipality together with Noau Officina Culturale and together with the Pro Loco of Vernante announce the 1st 'Attilio Mussino' International Illustration Competition.

Art. 2

The International Competition is open to illustrators and participation is free of charge.

The Competition aims to compare and exchange artistic and creative experiences.

Art. 3

The prize-giving ceremony for the winner will take place in Vernante in September during the festival Imaginé.

Art. 4

Contestants must submit works in free technique, presenting reflections and representations on the theme: **Split Your Sides with Laughter!**

One vertical board per candidate will be allowed to be sent in digital format to info@festivalimagine.it by **Friday 14 March 2025**.

Art. 5

Italian and foreign illustrators may participate in the Competition.

Art. 6

The Award has a dedicated jury that will evaluate and select the best proposal. The jury's judgement is final and irrevocable.

Art. 7

The first prize of the competition consists of a 500 euro compensation and the winner will be a guest at the Imaginé Festival.

The illustrations considered most deserving by the jury will be part of the digital catalogue of the exhibition and will be exhibited during Imaginé, a small festival of storytelling for figures.
